







The legal voters of the Williston Town School District are hereby notified and warned to meet at the Williston Central School auditorium on Monday, March 1, 2010, at 7:00 p.m. to transact any of the following business not involving voting by Australian Ballot. Following the meeting the Board of School Directors will review the School District budget and Australian Ballot articles and answer any questions which may be presented.


- ARTICLE I:** To elect a moderator.
- ARTICLE II:** To hear and act upon the reports of the Williston School District Officers.
- ARTICLE III:** Shall the voters of the Williston Town School District authorize the Board of School Directors to borrow money by issuance of bonds or notes not in excess of anticipated revenues for the next fiscal year.
- ARTICLE IV:** Shall the voters of the Williston Town School District authorize the School District to hold its Annual Meeting on Monday, February 28, 2011?
- ARTICLE V:** Shall the voters of the Williston Town School District authorize the Board of School Directors to provide a mailed notice of availability of the Annual Report to residents in lieu of distributing the Annual Report?
- ARTICLE VI:** To transact any other business proper to come before said meeting.

BALLOT QUESTIONS

The legal voters of the Williston Town School District are hereby notified to meet at the Williston Armory at 7:00am at which time the polls will open until 7:00pm, at which time the polls will close, on Tuesday, March 2, 2010 to vote by Australian Ballot upon the following articles:

- ARTICLE VII:** Shall the Williston Town School District adopt a budget of Sixteen Million, Four Hundred Seventy-Eight Thousand, Three Hundred Fourteen Dollars (\$16,478,314) for the school year beginning July 1, 2010 and ending June 30, 2011?
- ARTICLE VIII:** Shall the voters of the Williston Town School District authorize the Board of School Directors to apply Fifty Thousand Dollars (\$50,000) of the school district's current fund balance as revenue for the 2010-2011 operating budget and apply the remaining balance as revenue for future budgets.
- ARTICLE IX:** Shall the voters of the Williston Town School District authorize the Board of School Directors to borrow money by issuance of notes not in excess of One Hundred Five Thousand Dollars (\$105,000) for the purpose of purchasing one (1) school bus.
- ARTIVLE X:** To elect for the Champlain Valley Union High School District No. 15, two (2) Directors for a term of three (3) years, beginning in March 2010.
- ARTICLE XI:** To elect one (1) Town School Board Director for a term of three (3) years beginning in March, 2010.
- ARTICLE XII:** To elect one (1) Town School Board Director for a term of two (2) years, beginning in March, 2010.


